### VETERINARY EXAMINATION FOR DYNAMIC SYNDICATIONS

At the request of Dynamic Syndications, a pre-sale veterinary examination of **Lot 135**, **WITCHES - 4YO Brown Mare by LONHRO ex QUIJA**, brands as described in the 2017 INGLIS Melbourne Autumn Thoroughbred Sale Catalogue, nr. Sh., Capital D inside circle, off Sh., 27 over 3 was carried out at the Inglis Sales Complex, Oaklands Junction VIC, on the 25th August 2017, prior to the commencement of the Inglis sale.

#### **Clinical Examination:**

She was well conformed high quality mare. An athletic sprinter type with deep girth and good length of rein. Standing approximately 15.3hh, she was presented in good condition. The mare has been spelling for approximately 4 weeks. All clinical parameters were found to be within normal limits. She was examined in hand, and was found to be free moving. Flexion tests were within normal limits. Stethoscope examination of heartbeat was normal. There was no clinical evidence of wear or injury to her extremities.

Full disclosure of this horse's veterinary history was available for inspection. Having read the file there were no historical issues of any significance noted.

#### **Radiographic Examination:**

X-Ray inspection was unable to be undertaken because conditions of sale do not require the vendor of any lot to submit X-Rays.

#### **Endoscopic Examination:**

Pre-sale the upper respiratory tract was examined endoscopically and the larynx and pharynx were found to be normal in appearance and function.

#### **Conclusion:**

In my opinion, at the time of this examination, Lot 135, WITCHES - 4YO Brown Mare by LONHRO ex QUIJA, is in so far as can be determined from the examination conducted, suitable for racing and public syndication and as such, is therefore suitable for all risk mortality insurance cover.
