VETERINARY EXAMINATION REPORT FOR DYNAMIC SYNDICATIONS

I confirm that on behalf of Dynamic Syndications, I was asked to appoint a veterinarian to represent them at the 2020 **Tattersalls Horses-In-Training Sale**.

Having a previous working relationship with **Dr. Michael Shepherd**, a **partner at RosSDales and Partners, Newmarket**, he was contracted.

I contacted Dr. Shepherd and explained what aspects we were searching for in a candidate to purchase to race in Australia.

A veterinary examination on each lot of interest to Dynamic Syndications was carried out at the **TATTERSALLS SALES COMPLEX, NEWMARKET, SUFFOLK, UK**, on the **26th 27th and 28th October 2020**. Prior to All Lots being offered on their Day of Sale, I received a written veterinary examination certificate relating to each horse Dr. Shepherd inspected.

I confirm that I read the report pertaining to **Lot 773 JACK DUGGAN (USA), a Northern Hemisphere 2yo Grey Gelding (a Southern Hemisphere 3yo Grey gelding) by JACK MILTON (USA) ex UNBRIDLED TREASURE (USA)**.

I supplied Dynamic Syndications my appraisal that this 2yo gelding was considered suitable for their purchase and for public syndication.

He was considered to be a high-class gelding. Well conformed, standing over good ground. Athletic with good scope, with a classical staying conformation. Standing approximately 15.3hh, he was presented in excellent condition. The gelding has been in full training and racing well. All clinical parameters were found to be within normal limits. He was examined in hand, and was found to be free moving. Flexion tests were within normal limits. Stethoscope examination of heartbeat was normal. There was no clinical evidence of wear or injury to his extremities.

A post sale blood test was undertaken to determine for the presence of any steroids or drugs in the system. None were detected.

A secondary blood test for the Piroplasmosis Virus was undertaken post sale to determine if the horse was a carrier. No abnormality was detected.

Radiographic Examination:

X-Ray inspection was unable to be undertaken because conditions of sale do not require the vendor of any lot to submit X-Rays.

Endoscopic Examination:

Pre-sale the upper respiratory tract was examined endoscopically and the larynx and pharynx were found to be normal in function.

Post-sale a Wind Test was performed endoscopically and the larynx and pharynx were found to be functioning normally.

Conclusion:

In my opinion, at the time of this examination, **Lot 773, JACK MILTON (USA) - A Southern Hemisphere 3YO Grey Gelding (2YO Northern Hemisphere) by JACK MILTON (USA) ex UNBRIDLED TREASURE (USA)** is in so far as can be determined within the limitations of the examination conducted by **Dr, MICHAEL SHEPHERD,** considered suitable for racing and public syndication and as such, is therefore suitable for all risk mortality insurance cover.

I confirm that I advised Dynamic Syndications that in my opinion this lot was suitable for purchase.

Client Clinical Notes

This is a very sound gelding, however his endoscopic assessment shows his laryngeal function to be on the weak side of normal.

IMPORTANT: The scope of a pre-bid examination of a horse at auction is necessarily and significantly limited (see notes overleaf). Abnormalities may therefore be undetected, or their significance underestimated. as a result of the limited scope of this examination.
