## VETERINARY EXAMINATION FOR DYNAMIC SYNDICATIONS

At the request of Dynamic Syndications, a veterinary review was conducted on the X-rays and the Endoscopic evaluation lodged in the repository for **Lot 464, LOPE DE VEGA (IRE) ex PRINCESS LAYAN (IRE) Chestnut Yearling Colt**, brands **Capital Y inside Circle** nr shoulder, **160** over **2** off shoulder, as described in the 2024 Inglis Melbourne Premier Yearling Sales Catalogue.

I reviewed these remotely via the Inglis sale portal. This was carried out on the **4th March 2024**, prior to the commencement of the sale day.

### Clinical Examination:

Dynamic Syndications advised that Dr. David Garth, Sydney Equine Practice, had conducted the physical inspection at the sales complex and has supplied a veterinary certificate. There was no clinical evidence of wear or injury to extremities. This clinical health check included: temperature, pulse, respiration, thoracic auscultation, an eyesight ophthalmological examination, mucous membrane colour, musculature symmetry and basic conformation, with no abnormalities found. He was examined in hand and was found to be free moving. There was no lameness at the walk and trot. On palpation and manipulation of the distal limbs including major joints, no abnormalities were found.

### Radiographic Examination:

This was carried out at Bimbadeen Park, Agnes Banks, NSW, on Thursday **28<sup>th</sup> March 2024**, to ensure the promoter had a current veterinary certificate prior to lodging documents for approval with Racing NSW as lead regulator.

### Clinical Examination:

He remains a well conformed, quality individual presented in good condition. He is a strong style of individual, athletic, with conformation that suggests a Spring 3yo who should lengthen to a Mile to 2000m. He has a good length of rein and a deep girth. He stands over good ground. The colt is still quite immature and will develop and strengthen further over the next 6 months. All clinical parameters were found to be within normal limits. ## VETERINARY EXAMINATION FOR DYNAMIC SYNDICATIONS

At the request of Dynamic Syndications, for compliance purposes, a veterinary examination was conducted on the **LOPE DE VEGA (IRE) ex PRINCESS LAYAN (IRE) Chestnut Yearling Colt**, brands **Capital Y inside Circle** nr shoulder, **160** over **2** off shoulder, as described in the 2024 Inglis Melbourne Premier Yearling Sales Catalogue. I had previously inspected this colt on **28 March 2024**. The purpose of the re-examination request was for the promoter to meet ongoing compliance with regulatory requirements by supplying a current veterinary certificate for inclusion with their PDS prior to lodging all documents for approval with Racing NSW as lead regulator.

### Clinical Examination:

This re-examination was conducted on **15th July 2024**. The colt is currently spelling, having recently been in training at Bimbadeen Park, Werombi, NSW. He remains a well conformed, quality individual presented in good condition. He is a strong style of individual, athletic, with conformation that suggests a Spring 3yo who should lengthen to 2000m. He has a good length of rein and a deep girth. He stands over good ground. The colt is still immature and will develop and strengthen further over the next 6 months.

There was no clinical evidence of wear or injury to extremities. This clinical health check included: temperature, pulse, respiration, thoracic auscultation, an eyesight ophthalmological examination, mucous membrane colour, musculature symmetry and basic conformation, with no abnormalities found.

He was examined in hand and was found to be free moving. There was no lameness at the walk and trot. No response to hoof testers was found. On palpation and manipulation of the distal limbs including major joints, no abnormalities were found. The colt displays a quiet temperament.

The colt remains a high-quality individual, athletic and free moving. He is well conformed and well balanced. The colt has grown significantly since he was purchased however is still immature and will develop further. No radiographs, blood tests, drug sampling, ECG or upper respiratory endoscope were performed. All clinical parameters were found to be within normal limits.
