VETERINARY EXAMINATION FOR DYNAMIC SYNDICATIONS

At the request of Dynamic Syndications, I was asked to re-examine the **SO YOU THINK ex SULTAH 2023 Bay 2YO Colt**, brands **Capital C** nr shoulder, **111** over **3** off shoulder, to assess its continued suitability for public syndication. The purpose of the re-examination request was for the promoter to meet ongoing compliance with regulatory requirements by supplying a current veterinary certificate for inclusion with their PDS.

I had previously inspected this horse twice on behalf of my client Dynamic Syndications. Firstly, at the Magic Millions Yearling Sale, Bundall, Qld on the **9th January 2025**, prior to the start of the Sale where a detailed pre-purchase inspection was conducted including a full set of x-rays being read and were considered **low risk**, and an endoscopic evaluation conducted which was **Grade 1** (normal). I advised my client at that time; in my opinion the colt was suitable for their purchase with an overall rating – **PASS, 8**. Secondly, I re-inspected the colt on the **5th May** as a follow up to supply a current veterinary certificate when my client was lodging documents with Racing NSW.

Clinical Examination:

This third examination was conducted at Bimbadeen Park, Werombi, NSW, on **1st October 2025**. The colt had been broken-in and educated in March and was then spelled. He was introduced to six weeks pre-training in June and has been spelling since mid-July. The colt has been spelling for 10 weeks and is ready to commence further training. This inspection was a general health check which included temperature, pulse, respiration, thoracic auscultation, as well as an ophthalmological examination for eyesight, mucous membrane colour, musculature symmetry and conformation. No abnormalities were found. The colt has a quiet temperament.

There was no lameness at the walk and trot in hand. No response to hoof testers was found. On palpation and manipulation of the distal limbs including major joints, no abnormalities were found. The colt remains a high-quality individual, athletic and free moving. He is well conformed and well balanced. The colt has grown significantly since he was purchased and has developed well. He is still immature and will develop further. No radiographs, blood tests, drug sampling, ECG or upper respiratory endoscope were performed. All clinical parameters were found to be within normal limits.

Conclusion:

In my opinion as at the **1st OCTOBER 2025**, the date of re-examination, **SO YOU THINK ex SULTAH 2023 Bay 2YO Colt**, is in so far as can be determined from the examination conducted, presents in good health and has passed clinical examination and remains suitable for all risk mortality insurance cover and is suitable for racing and public syndication.

VETERINARY EXAMINATION FOR DYNAMIC SYNDICATIONS

At the request of Dynamic Syndications, a veterinary examination of the bay thoroughbred yearling colt by **So You Think** out of **Sultah 2023** (as described in the Magic Millions Gold Coast Yearling Sale 2025 catalogue), was performed at Magic Millions Complex, Bundall, Qld. on the 9th January 2025.

Identification:

Clinical Examination:

The colt was presented in excellent clinical health, with even muscle mass and well conformed. He was a well-developed athletic colt. Upon examination all clinical parameters were found to be within normal limits. Ophthalmic examination determined no issues of concern. Auscultation of the thorax (chest) revealed a normal and regular heart rhythm at rest, with the colt having normal lungs sounds and normal respiratory rate at rest. At the time of this examination there were no issues of concern regarding his extremities. His genitalia was considered normal including two palpable descended testicles.

Repository:

The radiographic and pre scale upper airway endoscopy examinations pertaining to this horse lodged in the repository at the Magic Millions Bundall complex were examined and the findings were as follows.

Radiographs: Low Risk

Upper Airway Examination: Normal anatomy with Grade 1 function (Lane).

Conclusion:

In my opinion, at the time and within the limits of this examination the thoroughbred colt by **So You Think** out of **Sultah 2023** in so far as can be determined within the scope of this examination, is suitable for syndication and all risk mortality insurance cover.
